## REPRESENTATIVE MATTERS

- Negotiated a \$250,000 settlement with a home improvement and home elevation contracting company to resolve allegations it defrauded homeowners by abandoning construction projects being performed on Superstorm Sandy-damaged homes. The settlement included civil penalties and consumer restitution
- Negotiated a settlement with a national residential and automotive service contract company to resolve allegations that the company defrauded consumers by refusing to honor the terms of its contracts. The settlement included civil penalties, consumer restitution, and injunctive relief banning the company from operating in the state
